



In consideration for the execution or renewal of a lease of the dwelling unit identified in the lease, Manager or Owner and Resident agree as follows:

Resident, any member(s) of the resident's household, a guest or any other person affiliated with the resident on or off the resident premises:

1. Shall not engage in criminal activity, including drug-related criminal activity, on or off the said premises. "Drug related criminal activity" means the illegal manufacture, sale, distribution, use, or possession with intent to manufacture, sell, distribute, or use an illegal or controlled substance (as defined in Section 102 of the Controlled Substance Act [21 U.S.C. 802]).

2. Shall not engage in any act intended to facilitate criminal activity.

3. Will not permit the dwelling unit to be used for, or to facilitate criminal activity.

4. <u>Shall not engage in the unlawful manufacturing, selling, using, storing, keeping or giving of an illegal or controlled substance</u> as defined in N.R.S.453.566 and N.R.S.453.321, at any locations, whether on or off the dwelling unit premises.

- 5. <u>Shall not engage in any illegal activity, including, but not limited to:</u>
 - a: prostitution as defined in N.R.S. 201.295;
 - b: criminal street gang activity as defined in N.R.S. 193.168;

c: <u>assault and battery</u> as prohibited in N.R.S. 200.471, and N.R.S. 200.481, including domestic battery;

d: <u>the unlawful discharge of a weapon</u>, on or off the dwelling unit premises, as prohibited in N.R.S. Chapter 202; or

e: <u>any breach of the lease agreement that jeopardizes the health, safety and</u> welfare of the landlord, his agent, or other tenant, or involving imminent or actual serious property damage.

6. <u>VIOLATION OF THE ABOVE PROVISIONS SHALL BE A MATERIAL AND</u> <u>IRREPARABLE VIOLATION OF THE LEASE AND GOOD CAUSE FOR</u> <u>IMMEDIATE TERMINATION OF TENANCY</u>. A single violation of any of the provisions of this added addendum shall be deemed a serious violation, and a material and irreparable non-compliance. It is understood that <u>a single</u> <u>violation shall be good cause for immediate termination of the lease</u>. Unless otherwise provided by law, <u>proof of violation shall not require a criminal</u> <u>conviction</u>, but shall be by a preponderance of the evidence.
